The Chippewa County Road Commission will accept sealed bids until 1:30 p.m. on Wednesday, May 8, 2024 for the purchase of plastic and polymer coated, spiral wound CMP culverts to be used during the 2024 construction season. Please submit your bid to the Road Commission office located at 3949 S. Mackinac Trail, Sault Ste. Marie, MI 49783. All bids received will be publicly opened, read and tabulated at that time.

Bids submitted for consideration are to be in sealed envelopes and plainly marked "2024 Culvert Bids". Please allow time for your bid to get through the U.S. Postal Service. Mail drop off for the Road Commission is anywhere between 1:00 p.m. and 4:00 p.m. Any bids received after the specified date and time will be returned unopened. FAXED OR EMAILED BIDS WILL NOT BE ACCEPTED.

Bid specification forms can be obtained at the above address or by calling (906) 635-5295. Office hours are Monday – Friday from 6:00 a.m. to 3:00 p.m. They will also be available on our website at www.chippewacountyroads.org.

Bids shall become effective upon award, and bid price shall remain firm for the entire construction season. All culverts are to be delivered F.O.B. to the main garage facility in Sault Ste. Marie

Polymer coated CM pipe sizes 12" through 48" shall be 16 ga. material and 60" shall be 14 ga. material. CMP shall meet current MDOT specification. We are asking that all prices be quoted on a per foot basis for each size. Approximate quantity needed for all pipe sizes and types combined is 3,000 feet.
